#### **SWITZERLAND TO RECOGNISE CAM**



In 2009

### **Switzerland**

Through a popular vote and a change in its Constitution

became the first and so far only country in the West to recognise CAM in its public health system

### **CLAIMS** - New professions & recognised professional training

> 3 CAM professions



#### Allopathic trained physicians:

- Diploma in Complementary Medicine (CME)
  - reimbursed by the compulsory health insurances

### Practitioners without prior allopathic training:

2 new professions for CAM

- Federal Diploma in Alternative Medicine
- Federal Diploma in Complementary Therapy
  - reimbursed by complementary health insurances

# **CLAIMS** - Clinical practice & therapeutic products

- CAM units in medical faculties and university hospital centres
- CAM practice in public health settings

#### **DECISIONS & DECREES OF SWISS AUTHORITIES**

#### Decision of the Swiss High Court in 1996

Traditional medical systems do not have to prove their efficacy mainly according to criteria of modern streamline medicine but with respect to the particularities of their own system



### Decree of Swiss Health Ministry in 2014

Recognised CAM disciplines do no longer have to give proof of their efficacy, but any opponent should give proof of their inefficacy



#### Revision of the law on therapeutic products in 2015

In July 2015 the Swiss parliament has voted the revision of the law on therapeutic products with the scope to ease the access to medicines of traditional medical systems

#### AYURVEDA IN THE 3 CAM PROFESSIONS

Registered systems amongst 250 disciplines practised in Switzerland

- Alternative Medicine
  - → Ayurveda Medicine / TCM / Homeopathy / Naturopathy
- Complementary Medicine
  - → Homeopathy / Phytotherapy / Antrophosophic Medicine / TCM Ayurveda is proposed to become the 5<sup>th</sup> system within a 2 – 3 years
- Complementary Therapy
  - → Ayurveda Therapy / Yoga / Shiatsu / Cranio-Sacral ttt / Eutony

Ayurveda is the only discipline recognised in both new professions

#### **CAM SCENARIO IN SWITZERLAND**

Ayurveda has to compete for recognition beside major CAM systems who are stronger established

- TCM Chinese phytotherapy
- TCM Tuina massage
- Acupuncture
- TEN (Trad. European Naturopathy)
- Phytotherapy
- Homoeopathy
- Anthroposophic medicine

and 20-30 other CAM methods.


